Facts:-

- 1. RTI application dated 7 July 2011 was preferred before the CPIO, LIC of India, Divisional Office, Hyderabad to obtain information regarding panel of cashiers in City Branch III and procedures and criteria prescribed for empanelment and appointment of cashiers through eight points.
- 2. Vide CPIO order dated 4 August 2011, point wise information was furnished to the appellant which did not satisfy him.
- 3. Appellant preferred appeal dated 7 September 2011 before the first appellate authority.
- 4. Matter was decided vide FAA order dated 29 September 2011 vide which disclosure of information was denied under the provisions of section 8 (1)(j) of the Act.
- 5. Appellant preferred second appeal before the Commission.
- 6. Matter was heard today via videoconferencing from Hyderabad where both parties as above were present in person and made submissions.

7. After hearing both parties Commission directs as follows:

Point d): CPIO will provide a copy of the guidelines for appointment of cashiers issued by Central office of LIC of India.

Point h): CPIO will provide information regarding the names of the employees who worked as Cashier from of 1 January 2006. Information in respect of the period 2010 onwards has already been furnished.

8. Information as above to be provided within three weeks of receipt of the order.
