OFFICE MEMORANDUM

Sub: MAT liability in respect of closure of CPSEs under DPE guidelines dated 14.6.2018 -regarding

The undersigned is directed to refer to this Department's OM of even number dated 14.6.2018 vide which the revised guidelines on time bound closure of sick/ loss making CPSEs and disposal of movable and immovable assets were issued.

2. The CoS in its meeting held on 31.12.2018 regarding review of status of sick/ loss making CPSEs under closure, inter alia, recommended that DPE may, after due consultations, examine the possibility of issuing guidelines so that proposals for closure of CPSEs involving outstanding government loans being written off need to incorporate a provision for payment of applicable MAT.

3. In this regard, it is clarified that the administrative Ministry/ Department of CPSEs, while formulating proposals seeking approval of the Cabinet/CCEA for closure of their CPSEs under DPE closure guidelines dated 14.6.2018, shall estimate the applicable MAT liability in case the proposals inter alia involve waiver of outstanding Government of India loans (and accrued interest thereon) and include the same in the proposed budgetary support sought for funding closure under Para 4.1.8(i) of the said guidelines.

4. This has been issued in consultation with the D/o Expenditure vide OM No.20(11)/PE-II/2005 dated 7.2.2019.
