

It is proposed to fill up one post of Director (General Central Service, Group 'A', Gazetted, Non-Ministerial) in the pay scale (pre-revised) of Rs.37400-67000/- plus grade pay of Rs.8900/- Pay band-4, (revised as per 7th CPC) Level-13A in the pay matrix (Rs.1,31,100/-2,16,600/-) on deputation (ISTC) basis as per the existing notified RRs in Central Institute of Horticulture, Medziphema, Dimapur Distt., Nagaland, a subordinate office under Ministry of Agriculture & Farmers Welfare, Department of Agriculture, Cooperation & Farmers Welfare.

2. Eligibility Conditions:- Deputation (including short-term contract):

Officers under the Central/ State Government / Union territories/Public Sector Undertakings/Recognised Research Institutes/Agricultural Universities/Semi-Government or Statutory or autonomous organisations:-

(A) (I) holding analogous post on regular basis in the parent cadre or department; or

(II) with two years' service in the grade rendered after appointment thereto on a regular basis in pay band-4, Rs.37,400-67,000/- with grade pay of Rs. 8700/- in the parent cadre or department; and

(B) possessing the educational qualifications and experience as under:-

(I) Master's Degree in Agriculture with specialisation in Horticulture or M.Sc. (Horticulture) from a recognised University/Institute;

(II) Doctorate in Horticulture from a recognised University or Institute;

(III) 12 years Post Doctorate experience in the field of horticultural development/horticulture research.

3. Regulation of pay and other terms of deputation:-

The pay of the officer selected on "deputation" basis will be regulated in the scale of pay attached to the post in accordance with DOPT OM No. 6/8/2009-Estt. (Pay-II) dated 17.06.2010 as amended from time to time.

4. Age-limit:-

The maximum age limit for appointment by deputation (including short-term contract) shall not be exceeding fifty six years as on the closing date of receipt of applications.)

5. Period of deputation:-

Period of deputation (including short-term contract) including period of deputation (including short-term contract) in another ex-cadre post held immediately preceding this appointment in the same or some other organisation or department of the Central Government shall ordinarily not to exceed five years.
