

In this regard, it is informed that the competent authority has permitted, those twenty (20) candidates of IFS Exam-2019 who have requested the Ministry to grant them one year extension to join the service, to join the 96th Foundation Course (FC) with the RR batch-2021 (IFS Exam-2020). It may be noted that in view of the proviso below Rule 3(3) of Indian Forest Service (Regulation of Seniority) Rules, 1997, they will be assigned the subsequent year i.e. 2021 as the year of allotment instead of 2020, as already stated in clause-6 of offer of appointment to you. **It may also be noted that no further extension/relaxation of time will be granted.**

3. Further, the competent authority has granted exemption from attending the 95th FC to twenty-two (22) candidates of IFS Exam-2019 (as requested by them).
