<u>ORDER</u>

In continuation of this Department's Order of even number dated 24.12.2020, approval of the Competent Authority is hereby conveyed for promotion of the following 17 Assistant Section Officers (ASOs) of Central Secretariat Service (CSS) as Section Officers of CSS on ad-hoc basis, after having been found 'fit' by the Screening Committees in the meetings held in their respective Cadre Units and on being clear from vigilance angle, for a period upto 30.06.2021 or till the posts are filled up on regular basis, or until further orders whichever is earlier:

- 4. All these officers are posted in their respective Ministries/Departments on 'as is where is basis' on their promotion to the Grade of Section Officer on ad-hoc basis. Hence, the officers may be allowed to avail ad-hoc promotion in the Section Officers' Grade on 'as is where is basis' irrespective of sanctioned strength in their current place of posting. Posting orders in respect of surplus officers, if any, will be issued separately.
- 5. The ad-hoc promotion is subject to the following conditions:
 - i) The ad-hoc promotion will remain subject to outcome of:
 - (a) The SLP (C) No.30621/2011 arising out of final judgment and order dated 15.07.2011 in CWP No.13218/2009 passed by the Hon'ble High Court of Punjab & Haryana and other connected cases before the Hon'ble Supreme Court;
 - (b) The SLP (C) No.31288/2017 arising out of Hon'ble Delhi High Court judgment dated 23.08.2017 in WP (C) No.3490/2010 filed by the All India Equality Forum & Others vs. UOI & Ors and other related court cases in any competent court; and
 - (c) Any other court case in a connected matter

Brahn

- The period of adhoc promotion would be upto 30.06.2021 or date of superannuation or till the posts are filled up on regular basis or until further orders, whichever is earlier.
- iii) The adhoc promotion shall not confer any right to continue in the grade indefinitely or for inclusion in the Select List for regular appointments or to claim seniority in the Section Officers' Grade of CSS or for promotion to the next higher grade or for grant of NFS.
- iv) The adhoc promotion may be terminated at any point of time without assigning any reason there-for.
- v) The ad-hoc promotions will take effect from the date of assumption of charge of the post of Section Officer.
- vi) The exemption from mandatory training has been granted for ad-hoc promotions only. The officers promoted on ad-hoc basis shall have to undergo Level "B" training programme as and when nominated by this Department, unless they fall in the exempted category, before their regular promotions. Failure to do so may attract relevant provisions of CSS Rules 2009, and Regulations there-under and the Cadre Training Plan (CTP) for CSS officers, including reversion to their substantive grade i.e. ASO grade.
- vii) If any officer presently serving in the cadre, fails to assume charge of the post of Section Officer on or before 31.12.2020, without the prior approval of the Cadre Controlling Authority (DOPT) for extension of joining time, his/her ad-hoc promotion will be liable to be cancelled, apart from debarment from ad-hoc promotions or other suitable consequences.
- 6. Notification/order appointing the officers as Section Officer on ad-hoc basis will be issued by the Ministry/Department where they are being promoted on 'as is where is' basis.
- 7. While issuing the promotion order, the Ministry/Department shall ensure that it is clearly mentioned in the order that this ad-hoc promotion is subject to outcome of the court cases mentioned herein above and the other conditions mentioned in para 5 above.
- 8. A copy of the order issued should invariably be endorsed to this Department by Ministries/Departments on the same day of the assumption of charge of the promoted post through email (uscs1-dopt@nic.in).
- 9. The promotion of officers may be reflected in the **Web Based Cadre Management System** and the Nodal Officers of the Ministries/Departments concerned should ensure that the data in respect them are correct and up to date.
