OFFICE MEMORANDUM

Subject: -Draft Common Seniority List (CSL) for the Select List Year-2016 of SSA Grade-reg.

The undersigned is directed to refer to this Department's OM No. 12/2/2019-CS.II(B) dated 12.02.2019 vide which the "Zone of Consideration" for the **Select List Years 2016 and 2017** of SSA grade was issued. It has now been decided to circulate the draft Common Seniority List of SL-2016. The CSL for SL-2017 will be issued after nomination of candidates qualified through UD grade Limited Departmental Competitive Examination, 2017 which could not be held due to pending litigations.

2. The Draft Common Seniority List (CSL) of SSA of CSCS for the Select List Year, 2016 has been prepared in terms of Rule-3 of Section 6 of the Central Secretariat Clerical Service (Preparation of Common Seniority Lists) Regulation, 1971 as per the following parameters: -

- (i) The Draft Common Seniority List (Draft CSL) for the Select List 2016 of SSA grade has been prepared in terms of CSCS Rules, 1962 read with CSCS (Preparation of Common Seniority Lists) Regulations, 1971 as per the "inter-cadre seniority of the officials on decentralised basis.
- (ii) The officials have been placed in a block of four as far as possible (i.e. 3 senior most seniority quota officials followed by senior most LDCE qualified through UD Grade LDCE, 2016.
- (iii) The remaining un-interpolated officials have been placed as per their mode of recruitment in the grade of JSA included in SL-2008 in the following manner: -


S. No.	Inter-se seniority of JSA Grade	Method of preparing seniority
1	JSA who were promoted through length of service (SQ) against SL-2008	The seniority of persons referred to item (1) and item no. (2) are interpolated as per their date of joining in the grade of JSA and DE Rank in the ratio of 7:3 as far as possible.
2	JSA who were promoted LD Grade (for MTSs) Grade LDCE, 2008	

- (iv) The officials who have been appointed on compassionate ground and included in SL-2008 of JSA Grade, have been place at the bottom as per their date of joining.

3. The Cadre Units are requested to circulate the Draft List (Annexure-I) among the SSAs concerned under their administrative control inviting objections/representations, if any, with regard to any factual inaccuracy and the order of placement in the list. Cadre units are also requested to verify the correctness of the particulars such as date of birth, date of regular appointment to the grade of JSA (SQ), Rank No. (in the case of LDCE of JSA/SSA) and date of joining of compassionate appointees mentioned in the lists. If any name has been left out or included inadvertently, it may be brought to the notice of this Department with relevant details of his/her placement in the Draft CSL circulated herein. The draft CSL may be seen / downloaded from the website of this Department i.e. <http://www.persmin.nic.in> → Department of Personnel & Training → Central Secretariat → Central Secretariat Clerical Service (CSCS) → Common Seniority List → OM No. 12/1/2021-CS.II(B) dated 11.02.2021.

4. The Cadre Units are, therefore, requested to consolidate and forward the factual inaccuracies/deficiencies, if any, in the Draft CSL of SSA for the SL- 2016 to this Department latest by 26.02.2021. If nothing is heard from any cadre units by the stipulated date, it will be presumed that there is no factual inaccuracy in the CSL and it will be finalized accordingly. Objection / representations received after 26.02.2021 will not be entertained.
