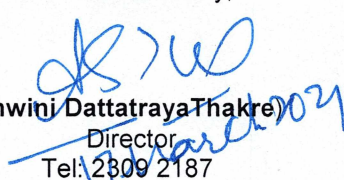
Sir/Madam,
