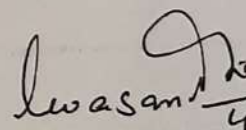
OFFICE MEMORANDUM

Subject: **Request for extension of joining time, Stenographer Grade 'D' 2018 -regarding.**

The undersigned is directed to invite a reference to this Department letter of even number dated 01.04.2021 offering appointment to the candidates selected in the Stenographer Grade 'C' & 'D' examination, 2018 conducted by SSC with the directions to join the post of Stenographer Grade 'D' in various Ministries/Departments of Central Secretariat by 15.4.2021. Many candidates have submitted requests seeking extension of time limit to join the post citing various reasons such as delay in getting relieved from the present office, different personal reasons etc.
