TERMS & CONDITIONS FOR ENGAGEMENT OF CONSULTANT AT DEPUTY
SECRETARY/DIRECTOR LEVEL IN THE MINISTRY OF DEFENCE


1. No. of consultants: Two (2)
2. Period of engagement: The engagement shall be initially for a period of 6 months, which is further extendable subject to satisfactory performance.
3. Scope of duties:
 - To list the reports/recommendations of various Committees/Task Forces on relevant issues post-independence and submit the summary/action taken report/implementation status for perusal of senior officers.
 - To coordinate and liaise with various Wings/Depts. Within MoD for the above work.
 - Any other work as assigned from time to time.
4. Eligibility: (A) Essential
 - Retired Officers at the level of DS/Director in the Government of India or equivalent level.
 - Experience in dealing with policy matters(B) Desirable

Should have worked in Ministry of Defence for at least 2 years.
5. Age: They should have attained not more than the 64 years of age as on the last date of receipt of application.
6. Remuneration: A fixed monthly amount shall be admissible, arrived at by deducting the basic pension from the pay last drawn at the time of retirement. The amount of remuneration so fixed shall remain unchanged for the term of contact. There will be no annual increment/percentage increase during the contract period.
7. Leave: The consultants will be entitled for the paid leave at the rate of 1.5 days for each complete month of service. Accumulation of leave beyond calendar year may not be allowed. In special circumstances, the Consultant could be called for services on holidays or beyond normal working hours for which no extra remuneration will be paid. However, for attending office on Saturday's/Sundays/Holidays, they may be given compensatory off.
8. House Rent Allowance: No HRA shall be admissible to the Consultants.
9. Transport Allowance: The Consultants shall not be allowed Transport Allowance for commuting between the residence and the place of work. However, they may be allowed TA/DA on official tour, if any, as per their entitlement at the time of retirement.

10. Confidentiality of record/data etc.: The Consultants will be governed by the Official Secrets Act, 1923, as amended from time to time and will not disclose to any unauthorized person(S) any information/data that may come to their notice during the period of their engagement as 'Consultant' in the Ministry. All such documents will be the property of the Government.
11. Tax deduction at Source: The Income Tax or any other tax liable to be deducted, as per the prevailing rules, will be deducted at source before effecting the payment for which the office will issue TDS certificate.
12. Termination of Consultancy: The engagement may be terminated at any time by the office without assigning any reasons by giving a notice of 7 days. In case, a Consultant desires to leave the assignment, he/she is to give 7 days' notice which can be curtailed/extended depending upon the workload.
