OFFICE MEMORANDUM

Subject: Promotion of Personal Assistants (PAs) of CSSS to Private Secretaries of CSSS on ad-hoc basis – regarding

The undersigned is directed to say that it has been decided to fill up the vacancies in the Private Secretaries grade of CSSS purely on ad-hoc basis by promoting the eligible Personal Assistants.

- 2. Accordingly, approval of the competent authority is hereby conveyed for issue of eligibility list in terms of approved service for consideration for promotion to Private Secretary's grade on ad-hoc basis as under:
- i) PAs of Select List 2016 as per **Annexure-I**
- ii) PAs of Select List upto 2015 who are still working as PAs subject to fulfillment of debarment conditions (OM dated 08.04.2011)
- 3. Successful completion of mandatory Level II training is one of the mandatory eligibility conditions for promotion of PAs as Private Secretaries. Therefore, in respect of PAs who are included in the eligibility list (PAs of 2016 and of previous Select Lists), Cadre Units may ensure that they have successfully completed Level -II Training or exempted (age 58+). The training status of the officer may be verified from service records accordingly.
- 4. The Cadre units of CSSS may conduct the DPC to assess the fitness or otherwise of the officers included in the eligibility list for their promotion to the grade of Private Secretaries of CSSS on ad-hoc basis. The recommendations of the DPC in respect of all the officers included in the eligibility list and working in the respective cadre unit along with vigilance clearance of the officers who have been found fit may be furnished by the cadre units with the approval of the competent authority to this Department (CS-II) in the prescribed proforma (Annexure-II) by 25.06.2021.

- If an officer who has been found fit by the DPC is currently undergoing penalty, such cases should also be informed to this Department with details such as date of imposition of penalty, period of penalty etc.
- Once the DPC recommendations are received, this Department would issue the promotion orders of all officers centrally. The officers who have been found fit by the DPC and clear from vigilance angle will only be given adhoc promotion. The promoted officers will be retained in the same cadre unit against existing vacancies in that cadre unit. The officers who are in excess of sanctioned strength will be transferred out in accordance with RTP provisions.
- will issue therefore, emphasized that cadre units 7. is, orders/notifications for appointment of officers as Private Secretaries on adhoc basis only after issue of the promotion orders centrally by this Department.
- The ad-hoc promotion of the officers will be subject to outcome on the following court cases:
 - The SLP (C) No.30621/2011 arising out of final judgment and order dated (i) 15.07.2011 in CWP No.13218/2009 passed by the Hon'ble High Court of Punjab & Haryana and other connected cases before the Hon'ble Supreme Court;
 - The SLP (C) No.31288/2017 arising out of Hon'ble Delhi High Court (ii) judgment dated 23.08.2017 in WP (C) No.3490/2010 filed by the All India Equality Forum & Others vs. UOI & Ors and other related court cases in any competent court; and
 - Any other court case in a connected matter (iii)
- The cadre units are once again requested to conduct DPC meetings 9. immediately along with vigilance clearance of the officers who have been declared fit and forward a copy of the minutes of Screening Committee duly approved by the Competent Authority, to this Department (CS-II Division) by 25.06.2021 positively.
