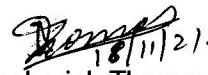
OFFICE MEMORANDUM

The undersigned is directed to refer to this Department's OMs No.6/6/2015-CS-I(S) dated 09.02.2015 and No.6/7/2015-CS-I(S) dated 04.03.2015 and subsequent reminders of even number dated 20.05.2015, 01.06.2015, 16.07.2015, 03.11.2015 & 21.03.2016 on the subject mentioned above.

However, the information about DPC recommendations in respect of a total of 18 officers (**Annexure**) included in the zone for SO SL 2013 & 2014 has not been received from the concerned cadre units till date.
