

2. मैं यह जानता/जानती हूं कि चयन सूची 2003 (विस्तारित) में वरिष्ठ सचिवालय सहायकों की वरीयता का मामला रिट याचिका सं. 8616/2019 और 8454/2019 में माननीय दिल्ली उच्च न्यायालय में निर्णयाधीन है, जिसमें माननीय दिल्ली उच्च न्यायालय ने दिनांक 23.12.2015 की स्थिति के अनुसार याचिका-कर्ताओं की स्थिति में परिवर्तन नहीं करने संबंधी माननीय केन्द्रीय प्रशासनिक प्राधिकरण द्वारा दिए गए निर्णय को यथापूर्व स्थिति के अनुसार बनाए रखने का निदेश दिया है। उपरोक्त निदेश के अनुसार, दिनांक 02.11.2015 को अधिसूचित चयन सूची-2003 (विस्तारित) में आने वाले वरिष्ठ सचिवालय सहायकों की स्थिति दिनांक 23.12.2015 को भी समान बनाए रखनी अपेक्षित है। चूंकि माननीय दिल्ली उच्च न्यायालय ने आवेदकों द्वारा दर्ज ओए सं.4700/2015 और 639/2016 द्वारा उठाए गए मामले में अपना अंतिम निर्णय अभी तक नहीं दिया है, इसलिए सहायक अनुभाग अधिकारी ग्रेड की वर्ष 2013 से आगे की चयन सूची तैयार नहीं की गई है।
3. मैं यह समझता हूं कि सहायक अनुभाग अधिकारियों की वर्ष 2013 (भाग-॥) के बाद की चयन सूची को अंतिम रूप नहीं दिया गया है, अतः 2018 के बाद से अनुभाग अधिकारी/आशुलिपिक सीमित विभागीय प्रतियोगी परीक्षा का आयोजन भी रुक गया है। मैं यह भी समझता हूं कि काफी संख्या में सहायक अनुभाग अधिकारियों, वरिष्ठ सचिवालय सहायक ग्रेड से पदोन्नत होकर तदर्थ आधार पर कार्यरत सहायक अनुभाग अधिकारियों सहित, से अभ्यावेदन प्राप्त होने पर, सरकार ने, उपरोक्त मुकदमों के

बावजूद चयन सूची, 2003 (केवल सीएसएल सं. 1966 के लिए) और चयन सूची, 2003 (विस्तारित) के सभी वरिष्ठ सचिवालय सहायकों को पूर्णतया अस्थायी आधार पर अनुभाग अधिकारी/आशुलिपिक सीमित विभागीय प्रतियोगी परीक्षा, 2018 में उपस्थित होने की अनुमति प्रदान करते हुए 2018 के लिए अनुभाग अधिकारी हेतु सीमित विभागीय प्रतियोगी परीक्षा आयोजित करने का निर्णय लिया है जो निम्नलिखित शर्तों के अधीन होगी:

- i. चयन सूची-2003 (विस्तारित) हेतु वरिष्ठ सचिवालय सहायक ग्रेड की सामान्य वरीयता सूची को अंतिम रूप दिए जाने तक तथा तत्पश्चात उपर्युक्त पैरा-1 में लंबित रिट याचिकाओं पर अंतिम निर्णय के आधार पर 2013 (भाग-11) से आगे के वर्षों के लिए सहायक अनुभाग अधिकारी ग्रेड की चयन सूची और माननीय दिल्ली उच्च न्यायालय द्वारा रिट याचिका के अंतिम निपटान के उपरांत दाखिल किसी अन्य न्यायालयी मामले के आधार पर भी, परीक्षा में शामिल होने से उम्मीदवारों को परीक्षा में उनकी पात्रता/चयन के लिए विचार किए जाने का कोई अधिकार प्रदान नहीं होगा।
- ii. संघ लोक सेवा आयोग द्वारा आयोजित परीक्षा (ओं) के अंतिम परिणाम की घोषणा, वर्ष 2013 (भाग-11) के लिए सहायक अनुभाग अधिकारियों की चयन सूची को अंतिम रूप दिए जाने के पश्चात परीक्षा में उनके प्रवेश की अंतिम रूप से पात्रता का निर्धारण होने के पश्चात की जाएगी, जो लंबित रिट याचिकाओं पर दिए गए निर्णय के परिणाम के बाद किया जाएगा।
- iii. यह कि, उपर्युक्त लंबित रिट याचिकाओं के अंतिम निर्णय के उपरांत वर्ष 2013 (भाग-11) के लिए सहायक अनुभाग अधिकारी ग्रेड की चयन सूची वरीयता कोटा के तहत तैयार की जाएगी और तदनुसार, जिन अधिकारियों के नाम सहायक अनुभाग अधिकारी चयन सूची-2013 (भाग-11) में होंगे और जो वर्ष 2018 की अनुभाग अधिकारी/आशुलिपिक सीमित विभागीय प्रतियोगी परीक्षा में अर्हक होंगे, उनके चयन को मान्य माना जाएगा।
- iv. अनुभाग अधिकारी/आशुलिपिक सीमित विभागीय प्रतियोगी परीक्षा 2018 के परिणाम की घोषणा, दिनांक 12.04.2002 के का.जा. सं. 36012/16/2019-स्था.(आरक्षण) के पैरा 5 के अनुसार जनरल सिंह बैच के मामलों के अधीन भी है।

4. उपरोक्त तथ्यों का अवलोकन करने तथा उन शर्तों को समझने पर जिनके तहत मुझे अनुभाग अधिकारी/आशुलिपिक सीमित विभागीय प्रतियोगी परीक्षा, 2018 में प्रवेश लेने की अनुमति दी जा रही है, मैं एतद्वारा यह स्वीकार करता हूं कि अनुभाग अधिकारी/आशुलिपिक सीमित विभागीय प्रतियोगी परीक्षा, 2018 के लिए मेरी उम्मीदवारी पूर्णतया अस्थायी है और उपरोक्त सभी शर्तों को मानने का वचन देता/देती हूं।

- v. Annexure-II(Revised) of the Corrigendum/Addendum issued vide No. 12/1/2011-CS.II(B) (Vol.II) dated 2nd November, 2015 (copy enclosed).

2. I understand that the issue of seniority of SSAs of 2003 (Extended) is under challenge in WP Nos. 8616/2019 and 8454/2019 in the Hon'ble High court of Delhi, where the Hon'ble Delhi High Court has directed to maintain status quo as granted by the Ld. CAT regarding non-alteration of the position of the petitioners as on date (23.12.2015). As per the above direction, the position of the SSAs belonging to SL-2003 (Extended) notified on 02.11.2015 is required to be maintained as on 23.12.2015. As the Hon'ble High Court of Delhi has not yet delivered its final judgement on the issue raised by the applicants in OA No. 4700/2015 and 639/2016, preparation of Select List of ASO Grade for 2013 onwards are pending.

3. I do understand that pending finalisation of Select List of ASOs for 2013 (Part-II) onwards, the SOs'/Stenos' Limited Departmental Competition Examination for 2018 onwards has been held up. I do further understand that consequent upon representation from a large number of ASOs including those working as ad-hoc ASOs after promotion from SSA grade, the Government despite the above-mentioned litigations, has decided to conduct the LDCE for SO for 2018 by allowing all the SSAs belonging to Select List 2003 (for CSL No. 1966 only) and SL-2003 (Extended) to appear the SOs'/Stenos' LDCE 2018 purely on provisional basis subject to the following conditions:

- i. That Appearing in the examination shall not confer any right on the candidates to consider his/her eligibility/selection in the examination till

finalization of Common Seniority List of SSA Grade for SL-2003 (Extended) and subsequently the Select list, 2013 (Part-II) onwards based on the final decision on the pending WPs mentioned in para-1 above and also in any other court case filed subsequently after final disposal of the WP by the Hon'ble High Court of Delhi-

- ii. That final results of the examination(s) conducted by UPSC shall be declared subject to determination of final eligibility to appear in the examination after finalization of the select list of ASOs for 2013 (Part-II), which will be finalized after the outcome of the decision on the above WPs.
- iii. That after the final outcome on the above-mentioned WPs the Select List of ASO Grade for 2013 (Part-II) under seniority quota will be prepared and accordingly the officials who would have figured in the ASO SL-2013 (Part-II) and qualified SOs'/Stenos' LDCE for 2018, their selection would be considered as valid.
- iv. That the declaration of the results of the SOs'/Stenos' LDCE, 2018 are also subject to outcome of the Jarnail Singh batch of cases as per para 5 of the O.M. No. 36012/16/2019-Estt.(Res.) dated 12.04.2022.

4. Having gone the above facts and understanding the conditions under which I am being allowed to appear in SOs'/Stenos' LDCE, 2018, I do hereby agree that my candidature for the SOs'/Stenos' LDCE, 2018 is purely provisional and undertake to abide by all the above conditions.

Subject: Special Upper Division Grade Limited Departmental Competitive Examination-2012-
Nomination of qualified candidates from the reserved list for appointment to Upper
Division Grade in CSCS against the Select List 2003(Extended) as per Ld. CAT's
order dated 1st August, 2016 in OA No. 794/2015 tilted Shri Kamal Kumar Gupta &
Ors. Vs UOI-reg.

The undersigned is directed to refer this Department's letter's number 12/1/2011-CS.II(B) dated 7th February, 2014 vide which this Division requested Staff Selection Commission to provide 140 candidates from the reserve/supplementary list on the basis of Special LDCE-2012 for accommodating them in SL-2003(Extended). SSC vide letter No. 9/1/2012-C-I/2 dated 02/05/2014 replied that "No reserved list is available in respect of UD Grade Limited Departmental Competitive Examination for extension of Select List-2003". Shri Kamal Kumar Gupta & Ors., the candidates who qualified written part of Special LDCE-2012 but could not be accommodated in the final list issued by SSC due to lack of vacancies, approached the Ld. CAT, PB by filling an OA No. 794/2015. Ld. CAT vide its order dated 01.08.2016 pronounced the final judgment and directed SSC to recommend additional 140 candidates out of the Special UD Grade LDCE-2012 for extension of Select list 2003. SSC decided to implement the order dated 01.08.2016 of Ld. CAT and furnished a list of 140 additional candidates (in order of merit) along with their dossiers. This Department, with the approval of competent authority, has also decided to implement the decision of the Ld. CAT and to accommodate them in SL-2003(Extended).

2. Accordingly, as per Rule 11(1) of the Central Secretariat Clerical Service Rules, 1962, as amended by this Department's Notification No. 12/3/93-CS.II dated 22.11.1995, the vacancies in the Upper Division Grade of the service in any cadre have to be filled by the regulator appointments of persons included in the Select List for the Upper Division Grade in that cadre. The said Select List is to be prepared in accordance with the provision envisaged in Regulation 2 (1) of the Third Schedule to the said Rules. According to that Regulation as amended by this Department's Notification No. 7/31/73-CS.II dated 4.2.1976, 25% of the vacancies are to be filled up on the basis of Limited Departmental Competitive Examination (LDCE) and 75% on the basis of seniority in the Lower Division Grade.

3. On the basis of the UD Grade Limited Departmental Competitive Examination for the Select List Year-2003(Extended), Staff Selection Commission has recommended 140 additional candidates for appointment as SSA in the Central Secretariat Clerical Service against the Select List Year-2003(Extended). Out of the 140 dossiers, it is observed that 72 officials are already figuring in SL-2003(Extended) under seniority quota. Thus, 68 officials, who are already working in SL-2004 to SL-2006 of SSA, are required to be shifted in SL-2003(Extended) under LDCE quota.

4. Since the 68 qualified candidates whose names are given in the Annexure-I to this O.M. are eligible for inclusion in the Select List Year of 2003(Extended) of SSA Grade, the concerned cadre units are requested to take immediate action to include them in SL-2003(Extended) of SSA in the respective cadre units. The dossiers of the candidates, as received from the SSC are sent herewith and these should be retained after their appointment as part of their personal files. It is requested that before these candidates are appointed, particulars of their service, caste etc., may please be checked and it may also be ensured that no Vigilance Case is pending or being contemplated against them.

5. Copies of appointment orders are required to be endorsed to this Department and the SSC latest by **20th September, 2017** so that this Division may take further necessary action as early as possible. If any candidate is not appointed to the grade of SSA due to any reason, his/her dossier may please be returned to the Staff Selection Commission directly under intimation to this Department after cancelling his / her offer of appointment and keeping all correspondences made with regard to his / her appointment, including cancellation letter, in the dossier.

6. The nomination to the said 68 officials under LDCE Quota in SL-2003(Extended) by shifting from SL-2004-SL-2006 under Seniority Quota as per this order would be subject to the outcome of the following court cases and also any other order(s) passed by any Competent Court in any of the concerned matters:-

- (i) In SLP No. 10342/2015 filed by Shri Pankaj Kumar Mishra & Ors before Hon'ble Supreme Court of India, New Delhi.
- (ii) In OA No. 4700/2015 filed by Ms. Sugam Arora & Ors before Ld. CAT, PB, New Delhi.
- (iii) In SLP(C) No. 30621/2011 and SLP(C) No.6195/2014 before Hon'ble Supreme Court of India, New Delhi.

7. It may please be noted that the candidates nominated from the aforesaid examination are required to be interpolated with persons included in the Select List through seniority quota in the ratio of 3 : 1(SQ : DE) as prescribed under CSCS Rules, as in force. However, the said interpolation will be done by this Division in due course subject to the outcome of court cases mentioned at para 6 above and also any other order(s) passed by any Competent Court in any of the concerned matters.

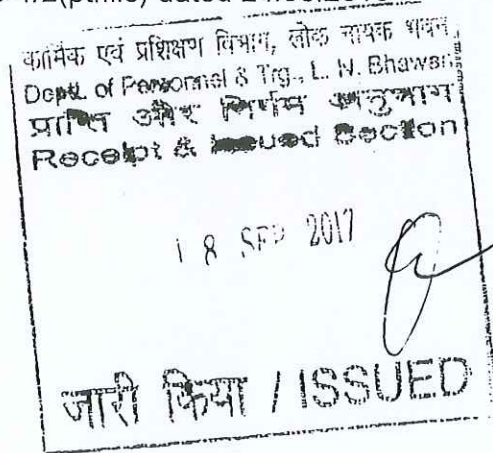
