OFFICE MEMORANDUM

Subject: - De-empanelment of Regency Hospital.

The Chief Vigilance Commission observed that The Regency Hospital treated a patient named Mrs Kamla Devi aged 48 years (58 years) against the Card No 4517562 belonging to Mrs Kamla Devi aged 85 years, grandmother of a serving official of CGHS, Kanpur on 21.12.2018. The Commission further observed that the patient admitted by proxy died during the treatment and her age was 48 years old (58 years) whereas the age of the original card holder was 85 years. Also, the card carries photographs of the beneficiary. Treatment of a patient against the CGHS card by proxy is highly unethical. Thus, clear complicity of the hospital towards the CGHS beneficiary has been established by the Commission. The Chief Vigilance Commission vide No. CVC OM No. Conf/10006/20/40159 dated 11.09.2024 and C-1308/03/2021-Vig, Government of India, MoH&FW, Vigilance Division dated 23.09.2024, received via email on 17.10.2024 in the office of Additional Director CGHS Kanpur, directed to de-empanel Regency Hospital Ltd., A-2 Sarvodaya Nagar, Kanpur, Uttar Pradesh.

Therefore, in compliance with the CVC direction, Regency Hospital Ltd., A-2 Sarvodaya Nagar, Kanpur, Uttar Pradesh is hereby de-empanelled from CGHS Kanpur, with effect from 11.11.2024, 12.00 o'clock midnight.

Further, Regency Hospital is given the following instructions: -

- 1) Regency Hospital shall not be allowed to provide diagnostic, OPD, IPD etc. treatment to CGHS beneficiaries and the hospital is not allowed to admit new CGHS Patients from 11.11.2024 12.00 midnight.
- 2) Regency Hospital is allowed to submit their claims on NHA Portal within 15 days commencing from 11.11.2024, after that they shall not be allowed to submit their claims.
- 3) Regency Hospital is directed to provide treatment to already admitted CGHS Beneficiaries till they become stable and get discharged. Their claims may be submitted on NHA Portal within 15 days, beyond that the hospital shall not be allowed to submit these claims on NHA Portal.

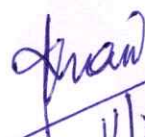
