

**Subject:-De-Empanelment of A S Kidney Hospital and Stone Centre Pvt. Ltd. RZ-A/70 Dashrathpuri, Adjoining Jindal public School Dabri New delhi-110045 from panel under CGHS Delhi & NCR.**

With reference to the above mentioned matter, the undersigned is directed to draw attention to the Office Memorandum No. **5-39/CGHS (HQ) HEC/2022 Part-II** vide which A S Kidney Hospital and Stone Centre Pvt. Ltd. RZ-A/70 Dashrathpuri, Adjoining Jindal public School Dabri New delhi-110045 was empanelled under CGHS Delhi/NCR w.e.f. 07.07.2023 as a non-NABH hospital and to state that this HCO was found indulging in repeated violations, non-compliance with CGHS empanelment conditions and submission of misleading and false information.

Keeping in view of the above, it has been decided to remove **A S Kidney Hospital and Stone Centre Pvt. Ltd. RZ-A/70 Dashrathpuri, Adjoining Jindal public School Dabri New delhi-110045** from panel under CGHS Delhi & NCR with immediate effect.
