**Sub: De-Empanelment of Kosmos Super speciality Hospital, C-60, Anand Vihar, (Vikas Marg) Delhi-110092 from the CGHS panel for a period of 6 Months.**

With reference to the above mentioned subject, the undersigned is directed to draw attention to the fact that Kosmos Super speciality Hospital, C-60, Anand Vihar, (Vikas Marg) Delhi-110092 was empanelled under CGHS. However The NABH Complaint Committee confirmed that your hospital's accreditation was kept in abeyance effective November 26, 2024, suspended on March 03, 2025, and forcefully withdrawn on August 14, 2025. You failed to intimate CGHS reg. this withdrawal, which is a mandatory requirement as per Clause 14 of the MoA dated December 22, 2025. Non-Disclosure of Fatal Fire Incident, Doubtful Billing Practices & Adverse Past Record the Competent Authority has decided to De-Empanel Kosmos Super speciality Hospital, C-60, Anand Vihar, (Vikas Marg) Delhi-110092 from the CGHS panel for a period of 6 Months & Forfeit 100% of the Performance Bank Guarantee (PBG) & Strict Scrutiny will be applied to the bills raised over the last one and a half years, and any excess or inadmissible amounts paid during this period will be recovered.

CGHS beneficiaries already admitted in the hospital for treatment prior to the issue of this order shall continue to be provided treatment at CGHS rates till their discharge.
