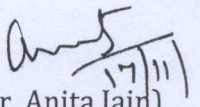

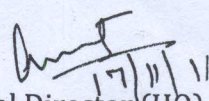

1.	Age	Not exceeding 62 years as on the date of issue of the advertisement
2.	Education Qualification	Minimum qualification required is of a MBBS Degree.
3.	Remuneration	Lumpsum amount of Rs. 46000/- Per Month.
4.	Duration of Application	Initially for a period of six month, this could be extended periodically on a si monthly basis.
5.	Number of vacancies	65 (Sixty five) but subject to change.
6.	Place of posting	The selected candidates will be posted in any CGHS dispensary in Delhi & NCR area and they will be functioning under the control of the Chief Medical Officer-in-Charge of the dispensary in which they are posted
7.	Preference	(i) Doctors who have worked in CGHS shall be preferred. (ii) Candidates having post graduate qualification in Clinical subjects will be preferred. (iii) In case suitable candidates are not available amongst those who have retired from CGHS, candidates from outside CGHS may also be considered.
