

NOTIFICATION

New Delhi, the 6th September, 2013

G.S.R.605(E).—In exercise of the powers conferred by sub-section (1) of Section 3 of the All India Services Act, 1951 (61 of 1951), read with Section 61(3) of the North-Eastern Areas (Reorganisation) Amendment Act, 2012 and sub-rules (1) and (2) of rule 4 of the Indian Police Service (Cadre) Rules, 1954, the Central Government, in consultation with the Government of Manipur, hereby makes the following regulations further to amend the Indian Police Service (Fixation of Cadre Strength) Regulations, 1955, namely:-

1. (i) These Regulations may be called the Indian Police Service
(Fixation of cadre Strength) Amendment Regulations, 2013.

(ii) They shall come into force from 24.12.2012.

2. In the schedule to the Indian Police Service (Fixation of Cadre Strength) Regulations, 1955, for the heading "**MANIPUR-TRIPURA**" and the entries occurring there under, the following shall be substituted namely:-
