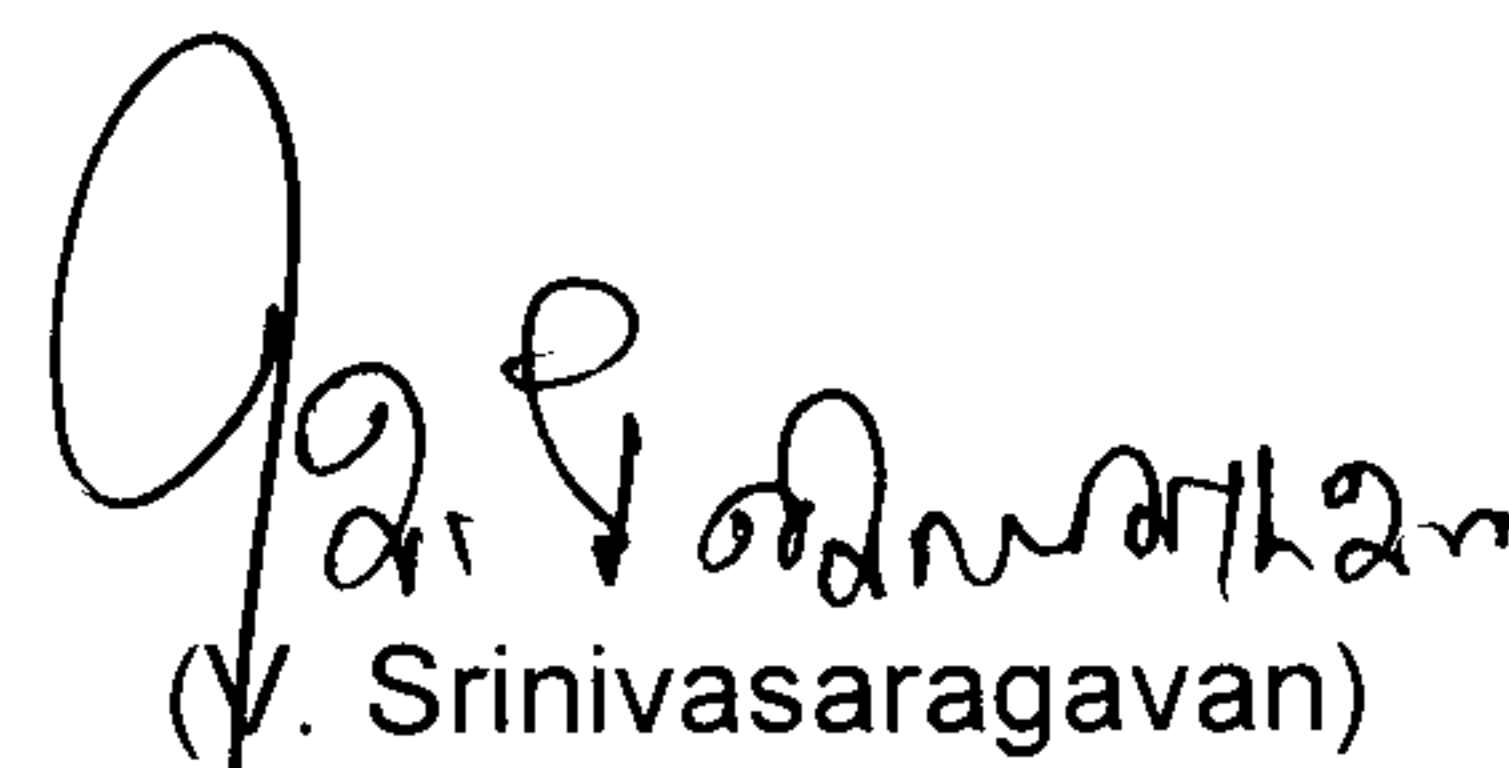

OFFICE MEMORANDUM

Subject: Posting on transfer and on promotion to US grade on ad-hoc basis –
seeking revised options – reg.

In continuation of this Department's O.M. of even number dated 03.03.2015 on the subject noted above, the undersigned is directed to say Shri A.S. Muraleedharan (CSL No. 8882) who was earlier indicated to be retained in UPSC is required to be transferred out of UPSC as he has been serving in UPSC since 2005 and completed the prescribed tenure under RTP.
