**ORDER**

In response to this Department's letter dated 13.2.2015, the Government of Nagaland have stated that they had erroneously communicated date of continuous officiation of promotee IAS officers as 1.10.1990. They have further mentioned that correct date of continuous Officiation of the promotee IAS officers in the post of Dy. Collector is 18.12.1985 and have requested to re-fix seniority/year of allotment of promotee IAS officers accordingly.
