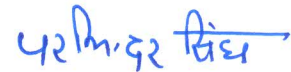

Subject: Posting of direct recruit Assistants undergoing Foundational Training organized by ISTM – options regarding.

The undersigned is directed to say that 536 direct recruit Assistants, selected on the basis of CGLE, 2013, are presently undergoing Foundational Training organized by Institute of Secretariat Training and Management at various training institutes. On conclusion of their training in the month of September, 2015, they will be posted to various participating Ministries/Departments of Central Secretariat Service. The list of Ministries/Departments and the number of vacancies proposed to be filled up in this round by these Assistants is given in Annexure-I.

2. It has been decided that the direct recruit Assistants will be posted in the order of their rank in CGLE, 2013 and preferences exercised by them.
