- iii) Copy of the undertaking obtained if any from the officers at the time of grant of stepping up of pay to the effect that excess payment, if any, will be refunded to the Government;
- iv) Copy of order issued for stepping up of pay in respect of these officers
- v) Copy of the orders issued for withdrawal/cancellation of stepping of pay

5. The Ministries/Departments are also requested to provide details of CSS officers, whose request for stepping up was not allowed, in the proforma attached as Annexure-II.
