**Minutes of the meeting with Ministries/Departments on the implementation of Bhavishya
held on 20/01/2017 at 3.00 P.M**

In order to implement 'Bhavishya' mandatorily w.e.f. 01/01/2017 in all Ministry/Department including attached/subordinate Offices; a review meeting was convened under the Chairpersonship of Additional Secretary, DoPPW with the following departments/offices:

- (i) Department of Science & Technology
- (ii) Ministry of Water Resources
- (iii) Ministry of Youth Affairs & Sports

2. The list of participants is at annexure –I.

3. Current Status:-

- Department of Science & Technology – All the 5 PAOs have been registered. Out of 51 DDOs, 30 DDOs are yet to be registered.
- Ministry of Water Resources - Out of 7 PAOs, 2 PAO are yet to be registered. Out of 116 DDOs, 17 DDOs are yet to be registered.
- Ministry of Youth Affairs & Sports – All PAOs i.e. 1 PAO has been registered. Out of 19 DDOs, 2 DDOs are yet to be registered.

4. After reviewing the status of the above mentioned Departments, the following action points have emerged:-

a. The representative of Department of Science & Technology has stated that all the functional DDOs have been registered and the rest are defunct and therefore, needs to be deactivated. Accordingly, they have also provide a list of functional as well as defunct DDOs.

Sh. A.S Sandhu, CCA, Ministry of Science & Technology has stated that his dashboard should be amended as while logging through his Email id, the details of NITI Aayog i.e., earlier office appears on the dashboard.

Action: NIC – DoPPW.

b. The representative of M/o Water Resources has requested for training and updation of the profile of the Nodal Officer. They have also requested to assign the role of PAO as well as DDO to the PAO Code No. 001765.

Action: M/o Water Resources & NIC- DoPPW.

c. Nehru Yuva Kendra Sanghathan, an autonomous organization under M/o Youth Affairs & Sports should be on board for BHAVISHYA and their 189 DDOs have to be registered.

Action: NIC- DoPPW.
