**ORDER**

The Government of Bihar vide their letter No. 1/c-1003/2016-GAD-1911 dated 17.02.2017 has sent a proposal for fixation of seniority of IAS officers appointed by selection from **Non-SCS** quota on the basis of inclusion of their names in the select lists of 2015. These officers have been appointed to IAS vide GOI Notification No. 14015/4/2016-AIS-(I)-B dated 23.02.2017.

2. The Seniority /year of allotment of these officers has been computed under Rule 3(3) (iii) of IAS (Regulation of Seniority), Rules 1987, as amended vide Notification No.14014/4/2011-AIS-I dated 05.05.2016 and other relevant rules. Modified Weightage formula is now as under:-
