OFFICE MEMORANDUM

Subject: Empanelment of private Health Care Organization (HCOs) under CGHS Delhi & NCR.

With regard to this Directorate's Office Memorandum dated 31.05.2023 regarding option to apply for empanelment in respect of 64 Health Care Organizations, which were removed from CGHS panel on 2nd May, 2022, the undersigned is to convey that in addition to the list of the hospitals (including dental clinics, eye centres and diagnostic laboratories already empanelled, the HCOs as per the list attached (Two HCOs - Annexure-A) have also been empanelled under CGHS in Delhi & NCR with issuance of this order. The newly empanelled HCOs may be treated as included in the existing list of empanelled health care organization under CGHS on same terms and conditions as have been indicated in the Office Memorandum dated 26.12.2017. The empanelment shall be till 30.09.2024 as with other empanelled HCOs or till finalization of new empanelment whichever is earlier. HCOs would claim NABH/NABL rates only for those investigations which are NABH/NABL accredited.
