Subject: Extension of Empanelment of AYUSH Hospitals / Centers under CGHS and CS (MA) Rules till 30.06.2019.

With reference to the above mentioned subject attention is drawn to the OM of even no. dated 26.12.2017 vide which non-NABH empanelled Ayush Hospitals/Centres were required to obtain NABH accreditation with in a period of one year from date of issue of the said OM. However some of the empanelled Non-NABH Ayush hospitals/ Centres have not been able to obtain NABH accreditation with in stipulated time period.

The matter has been reviewed and it has been decided to accord extension of validity of empanelment till 30.06.2019 to following Ayush Hospitals/Centres for obtaining NABH accreditation and in case of failure to do so, action as deemed fit would be initiated against these Ayush hospitals/ centres.
