Ltd., A-43, Hauz Khas, New Delhi – 110016 was empanelled under CGHS** and to state that **Dr. Khanna's Path Care Pvt. Ltd., Delhi** had violated the terms & conditions of MoA signed with CGHS by indulging in fraudulent practices. A show cause notice was issued to the laboratory and reply received was found to be unsatisfactory. In view of this it has been decided to suspend empanelment of **Dr. Khanna's Path Care Pvt. Ltd.** from CGHS for a period of three (3) months or till further orders whichever is earlier from the date of issue of this order.
