Subject: Nomination for Vigilance related training programme at GFSU, Gandhinagar (Gujarat)



2 The Commission will bear the expenditure on the course fee (Rs. 50,000) for all the participants. The expenditure on travel and boarding, lodging, local transportation including to and fro pick up and drop from airport/railway station to GFSU guest house [(Rs. 5,000 + 18% tax (if applicable)) /per person per day] will be borne by the organization to which the participants belong. In case the participants wish to make their own stay arrangements they may do so after intimation to GFSU. **Considering the delay by the participants in making the payment, GFSU requested that all the confirmed participants of the respective organizations to make the payment in advance to the GFSU. Otherwise, their participation will not be considered.** Details of the bank account will be shared separately by the Course Coordinator with the participants.
