Subject: Clarification regarding "NA certificate" on later date

In reference of circular F. No. 25(III)/DGEHS/243/DHS/2011/23773-82 dated 02/05/2012 (copy attached) whereby it was stipulated that Not Available (NA) certificate may be allowed to the beneficiary on later date as per records on the availability of the medicine on the date of prescription in the health facility (Dispensary/Hospital/Polyclinic).

Now, since Authorised Chemist facility has been implemented which supplies the unavailable indented medicine to pensioner beneficiaries at discounted rates, therefore, the Competent Authority has decided that, henceforth, "NA certificate" will not be issued to pensioner beneficiaries on a later date.
