DPE, in association with NTPC Limited, has developed a 'DRISHTI' Dashboard (<https://mapp.ntpc.co.in/drishti>) to facilitate real-time monitoring of progress of Action Plans of Central Public Sector Enterprises (CPSEs) in the context of CPSE Conclave-2018. All CPSEs and Ministries/Departments have also nominated their respective nodal officers who are responsible for uploading Action Plans and updating progress at regular intervals.

2. As per approved time-lines, the Action Plans of CPSEs are to be reviewed by the concerned CPSE on monthly basis, by the concerned administrative Ministry/Department on quarterly basis and by the Committee of Secretaries twice a year. The Committee of Secretaries had last reviewed the progress of Action Plans of CPSEs in May, 2019 and had, *inter-alia*, directed that Dashboard should be modernized and made more user friendly. In compliance, the Dashboard has accordingly been improved for better analytics. The details of new data/information required to be entered in the Dashboard had earlier been emailed to Nodal officers of CPSEs on 6<sup>th</sup> November, 2019 (copy enclosed).

3. In order to familiarise nodal officers of CPSEs about the new features of the Dashboard, DPE is organizing a Workshop on 27<sup>th</sup> January, 2020 at Power Management Institute (NTPC), Sector 16 A, NOIDA - 201301. The schedule of the workshop is enclosed. You are requested to direct the nodal officer of your company to update the Dashboard immediately and attend the workshop as per schedule along with relevant data/information and a laptop. ## Outline of modifications on the new DRISHTI Portal

For each 'Course of Actions' there could be one or more milestones. Weightage has been introduced for each milestone so that the cumulative weightage score is 100 for each Course of Action. Users need to enter milestone weightage, milestone start date, and Actual investment/Saving done for the completion of each milestone.

### Challenge I: Maximising Geo-Strategic Reach

1. 'Action Plan' is presently in free text, where user can enter any text. Now user will have to select 'Action Plan' from dropdown. There will be only three 'Action Plan', and from the list user will have to select one.
  - a) Acquire overseas assets to increase global reach
  - b) Capture international demand through export/investment
  - c) Acquire latest technologies through MoU / JVAll existing 'Course of actions' need to be mapped to one of the above 'Action Plan'.
2. 'Planned Investment' need to be entered in (Rs. Cr.) against each 'Course of action'.
3. 'Country name' to be mentioned from dropdown against each 'Course of action'. No. of countries may be one or more for each 'Course of action'.

### Challenge: Minimising Import Bill

1. 'Action Plan' is presently is free text, where user can enter anything. Now user will have to select 'Action Plan' from dropdown. There will be only four 'Action Plan', and from the list user will have to select one.
  - a) Increase domestic production
  - b) Source lower cost alternatives
  - c) Increase indigenous value added products and services
  - d) Develop new technologies to drive cost reduction
2. 'Current Import Bill' & 'Estimated Savings' need to be entered against each 'Course of action'.

### Challenge: Integration of Innovation & Research

1. 'Action Plan' is presently is free text, where user can enter anything. Now user will have to select 'Action Plan' from dropdown. There will be only two 'Action Plan', from the list user will have to select one.
  - a) Collaboration among CPSEs on specific R&D projects
  - b) Technological breakthroughs
2. 'Total Investment' need to be entered against each 'Course of action'.
3. 'Collaborating CPSEs' to be selected from dropdown against each course of Action.
