OFFICE MEMORANDUM

Subject: *Atma Nirbhar Bharat* initiative of the Government - requirement of skilled manpower regarding.

The undersigned is directed to state that the Government had announced the *Atma Nirbhar Bharat* (ANB) initiative in May 2020 to foster a quick and more robust economic recovery. It inter-alia comprised measures for MSMEs, migrants, farmers, and street vendors; governance reforms in agriculture, fisheries and food processing sectors; structural reforms in sectors viz. coal, mineral, defence, civil aviation, power, social infrastructure, space and atomic energy; and government reforms and enablers like increased allocation for the existing rural employment guarantee scheme; increased investments in public health to prepare for future pandemics; further enhancement of Ease of Doing Business, etc.

2. Some of the actionable points in the ANB initiative may entail requirement of trained/skilled manpower. In this context, it is mentioned that Ministry of Skill Development and Entrepreneurship (MSDE) can assist in meeting the skilling requirement involved in implementation of these schemes. To ensure that training undertaken is in sync with industry requirement, the MSDE has incubated 37 Sector Skill Councils. The Ministry through its Sector Skill Councils and other bodies has developed about 4,000 qualifications for varied sectors which are aligned with the competency framework and are available at the National Qualifications Register (www.nqr.gov.in). Moreover, MSDE has launched an ASEEM Portal viz. Atmanirbhar Skilled Employee Employer Mapping portal to enable employer to select from a registry of skilled employees.

3. To meet the skilled manpower required for implementation of actionable points under ANB, it is requested to visit the NQR and see the availability of job roles for which manpower may be available. Wherever, the job roles are not available but there is requirement, MSDE can facilitate training manpower according to requirement through its agencies like NSDC, DGT, etc. It is also requested that it may be made mandatory for agencies under your control to hire people with NSQF (National Skills Qualification Framework) skill certificates while implementing projects under ANB.
