This matter pertains to an RTI application dated 11.2.2013 filed by the Appellant, seeking information on seven points regarding action taken on his education loan application in respect of his daughter. The CPIO responded on 25.2.2013 and provided some information. Not satisfied with the reply of the CPIO, the Appellant filed an appeal to the First Appellate Authority on 1.3.2013. In his order dated 8.3.2013, the FAA provided a copy of the decision on the education loan. The Appellant approached the CIC in second appeal on 25.3.2013.

2. This matter pertains to an RTI application dated 15.1.2013 filed by the Appellant, seeking information on six points regarding payment of certain dues to him. The CPIO responded on 12.2.2013. Not satisfied with the reply of the CPIO, the Appellant filed an appeal to the First Appellate Authority on 21.2.2013. In his order dated 25.3.2013, the FAA provided some information concerning the dues paid to the Appellant. The Appellant approached the CIC in second appeal on 23.4.2013.

3. This matter pertains to an RTI application dated 31.3.2013 filed by the Appellant, seeking information on four points. The CPIO responded on 16.4.2013. Not satisfied with the reply of the CPIO, the Appellant filed an appeal to the First Appellate Authority on 22.4.2013. In his order dated 27.4.2013, the FAA upheld the CPIO's reply. The Appellant approached the CIC in second appeal on 17.5.2013.

4. We heard the submissions of the Appellant and the Respondents.

5. The CPIO is directed to facilitate inspection by the Appellant of the file, on which the education loan application of his daughter was processed, within thirty days of the receipt of this order. After such inspection, the Appellant should be given photocopies of up to twenty pages of the inspected records desired by him, free of cost.

6. The Appellant stated that even though the First Appellate Authority had provided some information concerning his dues, the queries in his RTI application, which related, inter alia, to delay in paying him his dues, have not been answered. The CPIO is directed to respond to the specific queries in the RTI application dated 15.1.2013, within thirty days of the receipt of this order, under intimation to the Commission.

7. The Appellant stated that he has not been provided information regarding details of the rental arrangements in respect of the premises of certain branches of the bank. In this context, we note that the Appellant had asked for information, inter alia, on names of landlords and the rent being paid etc. The bank had denied this third party information. The Appellant stated that he had sought this information because an accommodation, offered by him to the bank for renting, had been rejected. This, in our view, does not establish any larger public interest that would warrant the disclosure of this third party information. Accordingly, we note that the Appellant's RTI application dated 31.3.2013 has been acted upon and no further action is pending on it.

8. With the above directions and observations, the three appeals are disposed of.
