Facts:-

1. Shri Manish Kumar submitted RTOI application dated nil before the CPIO, National Insurance Company Limited, Kolkata to obtain information regarding the number of vacancies reserved for OBC category (Legal Post) along with the names of the selected candidates. Appellant also sought to have a copy of the rules under which in the event of tie in overall marks, candidates obtaining higher interview marks were ranked higher.
2. Vide CPIO order dated 2 September 2011, information was furnished.
3. Appellant preferred appeal dated 21 February 2012 before the first appellate authority.
4. Matter was decided vide FAA order dated 5 March 2012 by the first appellate authority vide which order of CPIO was upheld.
5. Appellant preferred second appeal before the Commission.
6. Matter was heard today via videoconferencing from Kolkata the first appellate authority was present. Appellant was heard from Varanasi.
