**Facts:-**

1. RTI application dated 12 May 2012 was submitted by the appellant before the CPIO, LIC of India, Western Zonal office, CRM Department, Mumbai to obtain information regarding allotment of lease to Shri Ghanshyam Das Damani and the use of these premises by M/s Real Life ATO System Pvt Ltd. through seven points.
2. Vide CPIO order dated 8 June 2012 appellant was informed that action had been taken as per the provisions of section 11 (1) of the Act and that the third-party had denied his consent for disclosing information that was personal to the third-party.
3. Appellant preferred appeal dated 20 June 2011 before the first appellate authority. 4. Matter was decided vide FAA order dated 14 July 2012 vide which the order of the CPIO was upheld.
5. Appellant preferred second appeal before the Commission.
6. Matter was heard today via videoconferencing from Mumbai where both parties as above were present and made submissions. Appellant stated that the lessee had given prior intimation of his intention to operate the office of M/s Real Life ATO System Pvt Ltd from the leased premises. Also that, notice had been issued to the lessee by the LIC of India.

7. After hearing both parties Commission directs the CPIO to provide information in writing to the appellant that Shri Ghanshyam Das had given prior intimation to the LIC of India before operating the office of M/s Real Life ATO System Pvt Ltd from the leased premises.

8. With reference to point 6 of the RTI application, the CPIO is directed to provide information to the appellant regarding the nature of notice issued to the lessee.

9. Information as above to be provided within one week of receipt of the order.
