**Meeting Notice**

**Subject: Presentation meeting on Software Module developed by DoPT for implementing online Vigilance Status of Board Level Executives of CPSEs - Inviting CVOs of Ministries/Departments**

With an objective to expedite the process of appointment of Board Level executives of Central Public Sector Enterprises (CPSEs), a decision has been taken at the highest level to introduce a technology based mechanism that enables efficient vigilance clearance of officers who apply for these senior level posts.

2. Pursuant to this decision, a web-portal for maintaining the data on vigilance status / profile of Board and below Board Level Executives of CPSEs has been developed for implementation. This would require feeding / updating of data pertaining to the details of employee's vigilance profile, i.e. pending disciplinary proceedings, status of complaints received, details of prosecution sanction, Agreed List, ODI etc. by the CVOs of Ministries/Departments in r/o Board Level Executives of their respective CPSEs, in the 1<sup>st</sup> phase.

3. The Ministries / Departments have already been issued directions on 19.01.2017 to start compiling and keep ready the data in respect of officers of CPSEs under their administrative control. The 'data entry' module of the system/software developed by NIC has been finalized and is ready for uploading of data by the CVOs of the Ministries/ Departments for Board level officers of CPSEs.

4. **In this regard, a meeting under the chairmanship of Secretary(Personnel) is scheduled to be held on 16.2.2017 at 2.30 PM in the Conference Room (Room No.119), North Block** wherein the NIC, DOPT will make a presentation of the online portal being developed for providing online vigilance status of Board Level Executives of CPSEs. Any issues likely to arise when the online system is implemented and data is uploaded on the portal by the concerned CVOs would be addressed in the meeting.

5. It is requested that the CVOs of the Ministries/Departments who are responsible for maintaining vigilance related data of board level executives of CPSEs under their administrative control, may be deputed to attend this meeting on the scheduled date and time.
