**OFFICE MEMORANDUM**


Subject: Zone of consideration for inclusion in Select List of Section Officers' Grade of CSS for the years 2012, 2013 and 2014 against Seniority Quota – regarding

The undersigned is directed to refer to this Department's OMs No.6/5/2015-CS-I(S) dated 06.02.2015, No.6/6/2015-CS-I(S) dated 09.02.2015 and No.6/7/2015-CS-I(S) dated 04.03.2015 vide which the zone of consideration for inclusion in Select List of Section Officers' Grade of CSS for the year 2012, 2013 and 2014 respectively were issued and subsequent reminder of even number dated 20.05.2015.

2. However, the information in respect of the DPC recommendations for all the officers included in the zone for all three years, complete in all respects, and about the corrective action taken in respect of orders/notification issued in respect of retired officer or officers who have not yet qualified the Level B training successfully, have not been received from majority of the cadre units. The status of information received/pending from the cadre units is available in the attached statement.

2. The Cadre Units are, therefore, once again requested to conduct the DPCs in respect of all officers included in the zone, who are/were working under their control immediately and furnish the requisite information in the prescribed proforma to this Department to enable early finalization of Select Lists for these years. The cadre units are also once again requested to take corrective action of:

- i) Orders/Notifications issued in respect of retired officers
- ii) Orders/Notifications issued in respect of officers, who are yet to qualify the Level B Training Programme (Notifications in these cases should be issued prospectively from the date of successful completion of the Level B Training)
