

With partial modification to the Vacancy Circular of number A-35018/7/2018-E.I dated 17.12.2018, Directorate General of Civil Aviation (DGCA) intends to fill up the **02 Posts of Deputy Director (Aircraft Engineering)** (General Central Service, Group 'A', Gazetted, Non-ministerial) in Level – 12 of the 7th CPC Pay Matrix on **Deputation (including short-term contract)** basis in the Directorate General of Civil Aviation (DGCA), Ministry of Civil Aviation, New Delhi. Applications are invited from eligible officials/officers under the **Central Government or State Governments or Union Territories or Universities or recognised research institution or Public Sector Undertakings or Statutory or Autonomous Organisations** fulfilling the following eligibility criteria and other conditions:-

- (a) (i) holding analogous posts on regular basis in the parent cadre of Department; or  
(ii) with five years' service in the grade rendered after appointment thereto on a regular basis in posts in level-I I in pay matrix in the parent cadre of Department; and
- (b) Possessing the following educational qualifications and experience:-
  - (i) Degree in Aeronautical Engineering or Electricals or Electronics or Mechanical or Metallurgical Engineering from a recognised university;
  - (ii) ten years' experience in aeronautical research and development or design or laboratory investigation of failed aircraft parts of Flight recorders involved in accident or incident or Airworthiness Engineering.

Note 1: The departmental officers in the feeder category who are in the direct line of promotion will not be eligible for consideration for appointment on deputation. Similarly, deputationists shall not be eligible for consideration for appointment by promotion.

Note 2: Period of deputation (including short term contracts) including period of deputation under the short term contract in another ex-cadre post held immediately preceding this appointment in the same or some other Organisation or Department of the Central Government shall ordinarily not to exceed four years. The maximum age limit for appointment by deputation (including short term contract) shall not be exceeding 50 years as on the closing date of receipt of applications.

Note 3: The maximum age limit for appointment by deputation (including short term contract) shall be not exceeding fifty-six years as on the closing date of the receipt of applications.

2. The terms & conditions and Pay & allowances of the officers selected for appointment on deputation basis will be governed as per the provisions contained in Government of India, D.P.P. No. 6/08/2009-Bst. (Pay II) dated 17.06.2010, as amended from time to time.

- (v) List of minor/major penalty, if any, imposed on the applicant during last 10 years.

4. Complete application with the above documents, duly signed by the authorized officer, should be forwarded through proper channel to the undersigned within 60 days from the date of advertisement in Employment News/Journal.

5. The candidates who apply for the post will not be allowed to withdraw their candidature subsequently.
