OFFICE MEMORANDUM

Subject: Continuation of ad-hoc appointments of SSAs of CSCS belonging to SL-2003(Extended) and SL-2004 to 2008 to the grade of ASO of CSS – reg.

The undersigned is directed to refer to this Department's O.M. of even number dated 10.06.2022 vide which the ad-hoc appointment of the SSAs of SL-2003(Original), SL-2003(extended) and SL-2004 to 2008 to the grade of ASO was extended upto 30.06.2022.

2. In the meantime, the zone of consideration for SL of ASO for 2013 (part) was issued vide this Department's O.M. No. 11/1/2022-CS.II(B) dated 22.05.2022 for grant of regular promotion of SSAs of SL-2003(Original) to ASO grade on regular basis.


3. With the approval of competent authority, the period of ad-hoc appointment of the SSAs of SL-2003(Extended) and SL-2004 to 2008, who are working as ad-hoc ASOs as on 01.07.2022, is hereby extended further up to 31.12.2022 or till the posts are filled up on regular basis or till the date of their superannuation / VRS etc. or till further orders, whichever is earlier.

4. Continuance of ad-hoc appointment shall not confer on the appointees any right to continue in the grade of Assistant Section Officer indefinitely or for inclusion in the Select List of Assistant Section Officer of CSS or to claim seniority in the grade of Assistant Section Officer of CSS.

5. The extension of ad-hoc appointment of the above SSAs in the ASO grade shall be subject to:

- (i) outcome of the the WP(C) Nos.5259/2019, 8454/2019 and 8616/2019 before the Hon'ble High Court of Delhi filed against the order dated 09.01.2019 passed by the Ld. CAT, PB, New Delhi in O.A. No.4700/2015 and 639/2016.
- (ii) further orders that may be passed by the Hon'ble Supreme Court of India in Jarnail Singh batch of cases (Civil Appeal No. 629 of 2022 arising out of SLP (C) No. 30621/2011).

6. A copy of the order extending the period of ad-hoc appointment of the SSAs in the grade of ASO (ad-hoc) should be endorsed to this Department.
