OFFICE MEMORANDUM

Subject: Continuation of ad-hoc appointment for SSAs of CSCS belonging to SL-2003, 2003(Extended) and SL-2004 to 2008 in the grade of ASO of CSS – reg.

The undersigned is directed to refer to this Department's O.M. of even number dated 17.06.2021 vide which the ad-hoc appointment of the SSAs of SL-2003(Original), SL-2003(extended) and SL-2004 to 2008 to the grade of ASO was extended upto 31.12.2022. Further, this Department vide OM No. 11/1/2022-CS.II(B) dated 22.05.2022 issued "Zone of Consideration" for regular promotion of the SSAs of SL-2003(original) to the ASO Grade.

2. With the approval of competent authority, the tenure of adhoc appointment of the SSAs of SL-2003(Original) and the SSAs of SL-2003(Extended) and SL-2004 to 2008, who are working as adhoc ASOs as on 1.1.2022, is hereby extended further upto **30.06.2022** or till the posts are filled up on regular basis or till the date of their superannuation/VRS etc. or till further orders, whichever is earlier. It is also stated that the ad-hoc appointment of these officers shall not be extended beyond 30.06.2022.

3. The terms and conditions as mentioned in the earlier OM of even number dated 17.06.2021 will remain the same. The extension of ad-hoc appointment in the ASO grade shall be subject to further orders that may be passed by the Hon'ble Supreme Court of India in the Jarnail Singh batch of cases (Civil Appeal No. 629 of 2022 arising out of SLP (C) No. 30621 of 2011).

4. Cadre Units of CSCS are also requested to take immediate action as envisaged in O.M. No. 11/1/2022-CS.II(B) dated 22.05.2022 so that all the SSAs of SL-2003(Original) who are working as ASO on ad-hoc basis, are regularized on or before 30.06.2022.

5. A copy of the order of extension of ad-hoc appointment in the grade of ASO (adhoc) should be endorsed to this Department.
