Subject: Inviting nominations for filling up the posts of CVO in CPSEs etc. for the financial year 2016-2017- reg.

The undersigned is directed to refer to this Department's letter of even number dated 17.11.2015, 19.11.2015, 18.01.2016 & 19.02.2016, wherein the last date of submitting applications by the individual officers was extended upto 29.02.2016. It is further informed that due to unforeseen circumstances, few vacancies of 2015-16 (copy enclosed) could not be filled up and are being carried forward to be filled up alongwith the vacancies of 2016-17.

2. Since there has been an increase in vacancies due to the carry forwarded vacancies, it has been decided that the web portal for online submission of applications by the individual officer **will be again opened till 30.04.2016** in order to give opportunity to the willing/eligible officers who have not applied earlier, to submit fresh applications.

3. It is however clarified that the officers who have already submitted applications online need not fill fresh applications. They may revise their choice of locations (against the unfilled vacancies of 2015-16) by sending a formal letter in hard copy directly to this Department, if they so desire, **positively by 30th April, 2016.**
