

### Terms of Reference

1. The National Committee will shortlist the 1<sup>st</sup>, 2<sup>nd</sup> & 3<sup>rd</sup> winning entries in each category by 25.10.2019 (Semi-final). The 1<sup>st</sup> winning entry shall be submitted online to the Organizer i.e. General Prosecutor's Office of Russian Federation for onward transmission to the International Jury for Finals. The National Committee will also shortlist 10 best posters and 10 best videos, in addition to the winning entries, for submitting them to the Organizer for posting on the official website [www.anticorruption.life/enfor](http://www.anticorruption.life/enfor) for exhibition (exposition) purpose. The National Committee shall submit all the semi-final shortlisted works to the Organizer latest by 31.10.2019.
2. The National Committee will assess the contest entries according to the following criteria: conformity to the stated theme; reasonableness, originality and in-depth coverage of the topic; creativity, novelty of the idea and quality of work performance; accuracy and clarity of the language and style of presentation; compliance of the work with the goals, objectives and restrictive requirements of the contest.
3. The winning entries (1<sup>st</sup>, 2<sup>nd</sup> & 3<sup>rd</sup>) at National level in each category shall be awarded prizes.
4. The Top/Prize winners will be felicitated in an award ceremony to be held in Moscow on 09.12.2019. The travel/air expenses of the winners and accompanying persons shall be borne by the sending country. The expenses for accommodation and meals of participants and accompanying persons during their stay in Moscow will be paid by the Organizer.
5. In the event of an Indian entry being declared as a winner, DoPT shall bear the travel expenses\* of the winning participant. In case the winner is under the age of 18 at the time of departure to Moscow, he may be accompanied by a guardian and DoPT shall bear the travel expenses\* for the same.

\*Travel Expenses: This will include Economy Class Air Fare (Air India only) and Taxi fare from Airport to Hotel and Hotel to Air Port. Expenses for accommodation and meals of participants and accompanying person will be provided by Russia.
