**OFFICE MEMORANDUM**

**Subject: Continuation of ad-hoc appointment for JSAs belonging to SL-2010 to 2012 to the grade of SSA of CSCS cadre – reg.**

The undersigned is directed to refer to this Department's O.M. No. 12/2/2020-CS.II(B) dated 30.12.2020 wherein the JSAs of SL-2010 to 2012 were granted ad-hoc promotion to the grade of SSA upto 30.06.2021. Now, with the approval of competent authority, it has been decided that the period of ad-hoc appointment of the Junior Secretariat Assistants of CSCS who are working as Senior Secretariat Assistant of CSCS on ad-hoc basis may be extended further upto **31.12.2021** or till further orders, whichever is earlier.

2. Continuance of ad-hoc appointment shall not confer on the appointees any right to continue in the grade of Senior Secretariat Assistant indefinitely or for inclusion in the Select List of Senior Secretariat Assistant of CSCS or to claim seniority in the grade of Senior Secretariat Assistant of CSCS.

3. The extension order of ad-hoc appointment as mentioned in para (1) above is subject to the following court cases: -

- (i) The SLP(C) No.30621/2011 arising out of the final judgment and order dated 15.07.2011 in WP(C) No.13218/2009 passed by the Hon'ble Court of Punjab & Haryana and other connected cases before the Hon'ble Supreme Court;
- (ii) The SLP (C) No.31288/2017 arising out of the Hon'ble Delhi High Court judgment dated 23.08.2017 in WP(C) No.3490/2010 filed by the All India Equality Forum & Ors. Vs UOI & Ors. And other related court cases in any competent court;
- (iii) The WP(C) Nos.5259/2019, 8454/2019 and 8616/2019 before the Hon'ble High Court of Delhi filed against the order dated 09.01.2019 passed by the Ld. CAT, PB, New Delhi in O.A. Nos.4700/2015 and 639/2016;
- (iv) Any other court cases in connected matter.
