**ORDER**

The Government of Maharashtra has sent proposal vide letter no.AIS-1016/C.R.447/2016/X dated 18.7.2016 for fixation of seniority / year of allotment to the officers appointed to IAS from **Non-State Civil Services** on the basis of inclusion of their names in select list for the **year 2015** (against vacancies arisen between 01.01.2015 to 31.12.2015).
