ORDER

Whereas, Shri Om Prakash Verma, a State Civil Service officer of Uttar Pradesh was appointed by promotion to the Indian Administrative Service vide this department's Notification No. 14015/22/2012-AIS.I(B) dated 27.11.2012, from the Select List of 2011;

And whereas, on the basis of his appointment from the Select List of 2011, Shri Om Prakash Verma was assigned 2002 as his year of allotment in IAS;

And whereas, the factual position was that the name of Shri Om Prakash Verma was also included in the consideration zone for Select List of 2010 at SI.No. 09. However, as the Selection Committee assessed as 'Unfit', he could not be included in the Select List of 2010.

And whereas, Aggrieved by non-inclusion of his name in the Select List of 2010 Shri OM Prakash Verma had filed OA No. 3342/ 2014 before the Hon'ble CAT, Principal Bench, New Delhi. The Hon'ble Tribunal vide its order dated 07.10.2016 disposed of the above OA with the following directions:-

"7. Thus, after consideration of all the judgments relied upon by the parties and the arguments advanced by them, we are of the opinion that the O.A. can be disposed of with the following directions:-

(i) Respondent No. 2 Govt. of U.P shall communicate to the applicant his APAR for the year 2005-2206 within two weeks from the date of receipt of a certified copy of this order.

(ii) The applicant can then make a representation for upgradation of the APAR within two weeks therefore.

(iii) In the event of such a representation being made, the Government of U.P shall decide the same in accordance with Rules within six weeks thereafter.

(iv) In case the applicant succeeds and there is a material change in his APAR, a review meeting of the Selection Committee shall be convened by the respondents to reconsider induction of the applicant in the IAS through the Selection List of 2010 with in eight weeks thereafter.

(v) if the applicant is found suitable then he shall be so appointed with all consequential benefits within six weeks thereafter.

8. Ordered accordingly. No costs."

And whereas, in compliance with the above order, the State Government, vide their letter dated 08.11.2017 submitted the proposal to the Union Public Service Commission for convening the Review Selection Committee Meeting to reconsider the name of Shri Om Prakash Verma for inclusion in the Select List 2010 for promotion to IAS of UP Cadre.

And whereas, thereafter, Union Public Service Commission, convened a Review Selection Committee Meeting on 23.11.2017 to reconsider the name of Shri Om Prakash Verma for inclusion in the Select List of 2010 for promotion to the IAS of Uttar Pradesh Cadre.

And whereas, on an overall assessment of his service records, the Review Selection Committee recommended the name of Shri Om Prakash Verma for inclusion at S.No. 4A below the name of Shri Narendra Kumar Singh at S. No. 4 and above the name of Shri Chandra Pal Singh at S.No. 5 in the Select List of 2010 for promotion to the IAS of Uttar Pradesh Cadre.

And whereas, Shri Om Prakash has thus become entitled for appointment to IAS from the Select List of 2010 instead of the Select List of 2011 and fixation of his seniority / year of allotment in IAS on that basis;

Now therefore, in pursuance of directions of Hon'ble CAT, Principal Bench contained in its order dated 07.10.2016 in OA No. 3342/2014 Sh. Om Prakash Verma (D.O.B. 15.07.1958) shall be deemed to have been appointed to IAS Cadre of Uttar Pradesh from the Select List of 2010 (his name shall be removed from the Select List of 2011) w.e.f. 27.11.2012 viz the date from which his immediate junior in the Select List Smt. Pushpa Singh was appointed to IAS. His name shall now accordingly be inserted at Sl. No. 4A in this department's Notification No. 14015/22/2012-AIS(I)A and Sl.No.3A in this department's Notification No. 14015/22/2012-AIS(I)B both dated 27.11.2012.
