ORDER

The Government of Bihar vide their letter No. 1/c-1003/2017-GAD-46 dated 25.09.2017 has sent a proposal for fixation of seniority of IAS officers appointed by selection from Non-SCS quota on the basis of inclusion of their names in the Select List of 2016.
