ORDER

The Government of Tamil Nadu vide their letter no. 653/2016-1 dated 19.11.2016 has sent a proposal for fixation of seniority of officers appointed on promotion from **Non-SCS** quota on the basis of inclusion of their names in the Select List of 2014-A. The officers have been appointed to IAS vide Notification No. 14015/21/2015-AIS-(I)-B dated 18.2.2016.

2. The Seniority /year of allotment of officers have been computed under Rule 3(3) (iii) of IAS (Regulation of Seniority), Rules 1987, as amended vide Notification No.14014/4/2011-AIS-I dated 5.5.2016 and other relevant rules. Since, the Select List 2014-A has been prepared in terms of ratio laid down in Praveen Kumar case as per this Department's O.M. No.22012/99/2009-AIS-I dated 17.3.2015.
