ORDER

The Appointments Committee of the Cabinet has approved the following:

- (i) Appointment of **Shri Sharad Aggarwal, IPS (AGMUT:1997)**, DIG, CBI as **Joint Director, CBI** from the date of assumption of charge of the post, for a tenure upto 31.05.2021 (5<sup>th</sup> year) or until further orders, whichever is earlier, against an existing vacancy;
- (ii) Appointment of **Shri Gajendra Kumar Goswami, IPS (UP:1997)**, DIG, CBI as **Joint Director, CBI** from the date of assumption of charge of the post, for a tenure upto 26.07.2020 (7<sup>th</sup> year) or until further orders, whichever is earlier, against an existing vacancy;

- (iv) Induction of **Shri Praveen Sinha, IPS(GJ:1988)**, Additional Secretary (JS level), CVC as **Joint Director, CBI** from the date of assumption of charge of the post, for a combined tenure of seven years upto 20.09.2022 or until further orders, whichever is earlier, against an existing vacancy;
- (v) Induction of **Shri Ajay Bhatnagar, IPS (JH:1989)**, IG, CRPF as **Joint Director, CBI** from the date of assumption of charge of the post, for an overall tenure of five years i.e. upto 31.08.2022 or until further orders, whichever is earlier, against an existing vacancy;
- (vi) Induction of **Shri Pankaj Kumar Srivastava, IPS (MP:1992)**, presently in the cadre, as **Joint Director, CBI** from the date of assumption of charge of the post, for a tenure of five years or until further orders, whichever is earlier, against an existing vacancy.
