O R D E R

Approval of the President is hereby conveyed for promotion of 17 Grade-I (Under Secretary) officers of the Central Secretariat Service (CSS) to the Selection Grade (Deputy Secretary) in the Pay Matrix level – 12 (Rs.78,800 – 2,09,200) [pre-revised PB-3 (Rs.15600-39100) with a Grade Pay of Rs.7,600/-] purely on 'ad-hoc' basis for a period upto 30.06.2019 or till the posts are filled up on regular basis, or until further orders, whichever is earlier.

2.1 All the officers as shown in the **Annexure-I** are posted in the Ministries / Departments mentioned against their names on their promotion to the Selection Grade (Deputy Secretary) on ad-hoc basis. The promotion of these officers will be effective from the date of assumption of charge as Deputy Secretary (adhoc) in the respective Ministry/ Department where they are posted to.

2.2 The posting of officers in respect of those who have returned from deputation to avail their promotion is given in **Annexure-II** and also directed to join immediately. The period for which the officers who remained under posting in this Department i.e. from the date of their reporting as Deputy Secretary (Ad-hoc) till issue of this order is treated as 'Compulsory Wait' and pay and allowances for this period will be paid to the officers by the Ministry/ Department in which they are now retained/ posted.

3. The 'ad-hoc' promotion is subject to the following conditions:


- (i) The ad-hoc promotion shall not confer any right to continue in the grade indefinitely or for inclusion in the Select List for regular appointment or to claim seniority in the Selection Grade (Deputy Secretary) of the CSS.
- (ii) Ad-hoc appointments may be terminated at any point of time without giving any reason thereof.
- (iii) The appointment on ad-hoc basis will take effect from the date of assuming the charge of the post of Selection Grade (Deputy Secretary) in the Ministry/Department in which the officer has been posted.
- (iv) The service rendered on ad-hoc basis in the Selection Grade (Deputy Secretary) would not count for the purpose of seniority in that grade or for promotion to the next higher grade.
- (v) The appointment is subject to vigilance clearance in terms of DoPT's OM No.22034/4/2012-Estt.(D) dated 02.11.2012 and other relevant instructions on the subject.
