2.1 As per Rule 4 of the IAS (Regulation of Seniority) Rules, 1987, the officer whose name has been mentioned at Sl. No.1 in the Select List 2018(SCS) shall be placed below Shri R. Lalramnghaka the junior most promotee IAS officer of 2009 batch (SL-2017 Mizoram Segment) and above Shri D. Manikandan, Senior most RR IAS officer of 2010 batch of Joint AGMUT cadre.

2.2 As per Rule 4 of the IAS (Regulation of Seniority) Rules, 1987, the officers whose name has been mentioned at Sl. No.2 to 4 in the Select List 2018(SCS) shall be placed below Shri Jitender Yadav, the junior most RR IAS officer of 2010 batch and above Shri Ravi Dhawan, Senior most RR IAS officer of 2011 batch of Joint AGMUT cadre.

3. Inter-se-seniority /year of allotment of the above officer with respect to officers of other segments would be determined later on as and when the inter-se-seniority of segments of AGMUT Cadre is decided by the Cadre Controlling Authority.
