No. 1 and 2 in the Select List of 2017(SCS Category) has been restricted under provisions of the rule 3(3)(ii) of IAS(Regulation of Seniority) Rules, 1987 which provide that an officer shall not be assigned year of allotment earlier than year of allotment assigned to other officer senior to him in that Select List or appointed on the basis of earlier Select List.

2.1 As per Rule 4 of the IAS (Regulation of Seniority) Rules, 1987, the officers whose name have been mentioned at Sl. No. 1 to 2 in Select List of 2017 shall be placed below Shri Sanjay Agrawal, the junior most promotee IAS officer of 2012 batch (SL-2016 SCS) and above Ms. Namrata Gandhi, the senior most RR IAS officer of 2013 batch of Chhattisgarh cadre.

2.2 As per Rule 4 of the IAS (Regulation of Seniority) Rules, 1987, the officer whose name mentioned at Sl. No. 3 of the select list of 2017 shall be placed below Shri Rajendra Kumar Katara, the junior most RR IAS officer of 2013 batch and above Shri Kundan Kumar, the senior most RR IAS officer of 2014 batch of Chhattisgarh cadre.
