2.1 As per Rule 4 of the IAS (Regulation of Seniority) Rules, 1987, officers mentioned at Sl. No.1 to 8 in the Select List of 2018 (SCS Category) shall be placed below Shri Kumar Pal Gautam, only RR officer IAS officer of 2009 batch and above Shri Prakash Rajpurohit, senior most RR IAS officer of 2010 batch of Rajasthan Cadre.

2.2 As per Rule 4 of the IAS (Regulation of Seniority) Rules, 1987, officers mentioned at Sl. No.9 to 10 in the Select List of 2018 (SCS Category) shall be placed below Shri Vishwa Mohan Sharma, the junior most RR officer IAS officer of 2010 batch and above Shri Mahaveer Prasad, only promotee IAS officer (Non-SCS Category –SL 2016) of 2010 batch of Rajasthan Cadre.
